Your delinquent report is now subject to enforcement action pursuant to IC 3-9-4-17. A person who has a delinquent campaign finance report is subject to civil penaltics of up to \$1,000.00 by the Allen County Election Board. An official Notice of Hearing is enclosed with the time and location details of a hearing that has been scheduled to discuss this matter.

We encourage you to attend this hearing however your attendance is not necessary or required. Failure to attend the meeting may result in a penalty being imposed against your committee by default. This penalty can only be appealed in Allen County Circuit Court.

A person notified by the Allen County Election Board that they may be assessed a penalty under IC 3-9-4-17 may enter into an agreement with the Election Board to pay the proposed penalty and waive a hearing before the board. The delinquent report must be filed no later than 7 days after the deadline and the agreement providing for the full payment of the penalty must be presented to the Election Board Office no later than 24 hours prior to the scheduled hearing.
