CAMPAIGN FINANCE TIPS FOR ALLEN COUNTY CANDIDATES

1. OPEN MY COMMITTEE (CFA-1)

Every candidate for nomination or election to an office, for which the compensation is at least \$5000 per year, must have a campaign finance committee.


The candidate must file the CFA-1:

- By noon ten (10) days after filing a declaration of candidacy; or
- By noon ten (10) days after receiving more than \$100 or making more than \$100 in expenditures; or
- By noon seven (7) days after the candidate filing deadline, whichever occurs first

Exceptions: Candidates running for an office for which the compensation is less than \$5,000, and School Board candidates are not required to file campaign finance report unless they receive more than \$500 in contributions or make more than \$500 in expenditures. A candidate who meets these standards must file the CFA-1 form no later than noon ten (10) days after they reach the \$500 maximum.

Precinct Committeemen and State Delegates are not required to open a campaign finance committee.

A candidate may be chairman, treasurer or both on their own committee.

2. FILE ON TIME AND AVOID FINES (CFA-4)

Campaign Finance Report Due Dates:

2021 Annual	Wednesday, 1/19/2022 Noon	(Reporting period ending 12/31/21 for open local candidate committees)
2022 Pre-Primary	Monday, 4/18/2022 Noon	(Reporting period ends 4/17/22 for Primary Candidates on ballot)
2022 Pre-Election	Friday, 10/14/2022 Noon	(Reporting period ends 10/13/22 for Candidates on General ballot)
2022 Annual	Wednesday, 1/18/2023 Noon.	(Reporting period ends 12/31/22 for open local candidate committees)

Candidates for local offices file reports with the Allen County Election Board and can be submitted in person, mail, fax or email.

3. CLOSE MY COMMITTEE (CFA-4)

- Committees do not automatically close if a candidate is defeated or the bank account has zero funds
- The committee must file a final disband report with the Election Board
- A committee must have a zero balance in order to disband

4. SUPPLEMENTAL "LARGE CONTRIBUTION" REPORT (CFA-11)

The candidate must file the CFA-11:

- If the committee receives contributions totaling \$1,000 or more after the pre-primary or pre-election reporting period ends
- Must be filed within 48 hours after receiving large contributions
